**Weather Advisory**

In view of the alert/weather warning issued by the Indian Meteorological department (IMD), Srinagar Station, widespread light to moderate rain/Snow at higher reaches are expected across Jammu and Kashmir including Shopian from **05<sup>th</sup> to 07<sup>th</sup> October 2025** with peak activity during 05<sup>th</sup> night to 07<sup>th</sup> morning. Considering the potential risks associated with these weather conditions, the general public is strongly advised to exercise utmost caution. To ensure public safety, the following precautionary measures must be strictly adhered to:

- All residents, especially those in hilly and higher altitude areas, are strongly advised to suspend all farming and outdoor activities during the forecast period.
- People are urged to stay indoors and avoid unnecessary travel, particularly in landslide-prone zones.
- All executing agencies including PWD, MED, BRO, Municipal Council are directed to activate men and machinery and trained personnel on priority.
- All concerned staff must be stationed at their respective Headquarters to ensure uninterrupted public service delivery.
- District Control Rooms and Disaster Management Teams remain on high alert.
